- 4. Dr. Pooja Jain suggested to add Recommendation System as one more application in NLP Applications of Unit VI of 'Natural Language Processing (PECCS708T)' course.
- 5. Dr. Latesh Malik suggested to include Embedded Systems Architecture, Programming and Design, book by Raj Kamal as one of the text books in 'Embedded Systems (PECCS712T)' course.
- 6. Mr. Kuldeep Singh Rana suggested to include prerequisite for Open Elective subjects.
