The Following agenda were discussed:

**AGENDA 1:** Consider and finalize Curriculum Syllabus of all courses for Second Semester.

Curriculum Syllabi of Cost and Management Accounting, Strategic Management, Entrepreneurial Development, Operation Management, Research Methodology, Financial Management-II, Human Resource Management-II, Marketing Management-II and Employability Skill Enhancement-II for second semester were discussed in detail. After due considerations following points were suggested:

1. Dr. Jasbir Singh Matharu suggested that one course outcome from each course can have an industry related flavor in it by either having expert lecture from an industry personnel or collaborating with the firm and learning it first-hand. He also suggested that collaborating with the firm and learning it first-hand may be implemented from the next batch. Dr. Himanshu Tiwari informed all the members that the department is planning to implement expert lecture from industry personnel in the upcoming semester.
2. Dr. Jasbir Singh Matharu suggested that in the course of Employability Skill Enhancement-II, the unit relating to Newspaper Analysis can be dealt by all the faculties as per their respective specialization. After a thorough discussion all the members were of the opinion to implement the suggestion.
