

He also mentioned that the NEP-2020 is implemented from the first year of engineering and will be made applicable progressively as per the guidelines issued by the Government of Maharashtra vide GR No. शासननिर्णयक्रमांक: एनईपी-2022/ (६७/२३) /तांशि-२ dated 4 जुले, 2023. Hon'ble member Dr. Chandrahas Handa appreciated the efforts of the institute and suggested maintaining the uniformity of the credits in each semester for all the departments as far as possible. Mr. Sanjeev Agrawal CEO clarified that the respective Board of studies tried it best to maintain the uniformity but in some subjects in the semester it was found difficult to have same credits in each semester. However, total number of credits in a year shall be altogether the same for all the subjects.

6/6: To apprise of the NEP Compliant Curriculum Scheme for I to VIII Semester of all B.Tech. Programs and Curriculum of First Year B.Tech. passed in the recent meeting of the Academic Council dated 19/07/2023.

The Dean-Academics explained the process of preparation of curriculum and its objectives. The respective Board of Studies have approved the NEP compliant scheme of all the departments of the institute and First year Engineering BoS also approved the scheme as well as syllabus of First year Engineering. The Dean-Academics briefed about the Exit Policy and informed the house that it is included in the NEP compliant Academic Rules and Regulations NEP Version 01.
